### Gym Membership Agreement

This Gym Membership Agreement ("Agreement") is entered into between Wayland Sports Gym, and the individual named below ("Member") as of the date of signing.

#### 1. Membership Obligations:

- Use of Facilities: The Member agrees to use the gym's facilities and equipment in a safe and responsible manner, following all posted rules, guidelines, and instructions provided by the gym staff.

- Payment: The Member agrees to pay the membership fees as outlined in this Agreement, either by recurring payments or in advance as specified.

- Compliance with Laws: The Member agrees to comply with all applicable laws, rules, and regulations related to health and safety while using the gym's facilities.

#### 2. Gym's Obligations:

- Termination by Gym: The gym reserves the right to terminate the Member's membership for non-compliance with the terms of this Agreement, violation of gym policies, or any other reasonable grounds specified in the Agreement.
- Membership Freeze or Suspension: The gym may offer options for temporary freeze or suspension of the membership, subject to any applicable fees or restrictions outlined in the Agreement.

### 4. Liability and Indemnification:

- Waiver of Liability: The Member acknowledges and agrees to release the gym, its owners, staff, and affiliates from any liability for injuries, damages, or losses incurred while using the gym's facilities or participating in its activities, to the extent permitted by law.

7. I authorize the Gym to use my name, likeness, and image in promotional materials and waive any right to compensation or other consideration for such use.
